# **Old Business**

- discussed the status of our 501c3 application with IRS which is still pending with IRS. David reports that we have paid \$600 so far to the accountant and \$400 to the IRS (filing fee) for a total outlay of \$1000 with \$800 still due to the accountant. The accountant will be paid \$200 per quarter or as funds become available.
